As to your comments specific to a public restroom, please be advised that both the Settlement and Community Benefit Agreement - between multiple entities, and the Park Construction Agreement - between the city and Lennar Homes, indicate that restroom buildings shall not be included with the park improvements on the Buena Vista Reservoir site. Therefore, a public restroom was not pursued as part of this project.
